1 PURPOSE

1.1 This policy establishes the definitions followed by the human research protection program.

2 REVISIONS FROM PREVIOUS VERSION

3 POLICY

- 3.1 Allegation of Non-Compliance: An unproved assertion of Non-Compliance.
- 3.2 <u>Authorization Agreement</u>: Also called a Reliance Agreement, is the agreement that documents respective authorities, roles, responsibilities, and communication between an institution/organization providing the ethical review and a participating institution relying on the ethical review.
- 3.3 <u>Certification</u>: The official notification by the institution to the supporting Federal department or agency component that a research project or activity involving human subjects has been reviewed and approved by an IRB in accordance with an approved assurance.
- 3.4 <u>Clinical Trial:</u> A research study in which one or more human subjects are prospectively assigned to one or more interventions (which may include placebo or other control) to evaluate the effects of the interventions on biomedical or behavioral health-related outcomes.
- 3.5 <u>Collaborative Study</u>: A study in which two or more institutions coordinate, with each institution completing a portion of the research activities outlined in a specific protocol.
- 3.6 <u>Conflicting Interest</u>: An individual involved in research review is automatically considered to have a conflicting interest when the individual or the individual's spouse, domestic partner, children, and dependents have any of the following interests in the sponsor, product or service being tested, or competitor of the sponsor held by the individual or the individual's immediate family:
 - 3.6.1 Involvement in the design, conduct, or reporting of the research.
 - 3.6.2 Ownership interest, stock options, or other ownership interest of any value exclusive of interests in publicly-traded, diversified mutual funds.
 - 3.6.3 Compensation of any amount in the past year or of any amount expected in the next year, excluding compensation for costs directly related to conducting research.
 - 3.6.4 Proprietary interest including, but not limited to, a patent, trademark, copyright or licensing agreement.
 - 3.6.5 Board or executive relationship, regardless of compensation.
 - 3.6.6 Reimbursed or sponsored travel by an entity other than a federal, state, or local government agency, higher education institution or affiliated research institute, academic teaching hospital, or medical center.
 - 3.6.7 Any other reason for which the individual believes that he or she cannot be independent.
- 3.7 <u>Continuing Non-Compliance</u>: A pattern of <u>Non-Compliance</u> that suggests the likelihood that, without intervention, instances of <u>Non-Compliance</u> will recur, a repeated unwillingness to comply, or a persistent lack of knowledge of how to comply.
- 3.8 <u>Designated Reviewer</u>: The IRB chair or an <u>Experienced IRB Member</u> designated by the IRB chair to conduct <u>Non-Committee Reviews</u>.
- 3.9 <u>Experienced IRB Member</u>: An IRB member is considered experienced if the IRB chair considers the IRB member to have sufficient experience in and knowledge of conducting IRB reviews.
- 3.10 <u>Expiration Date:</u> The first date that the protocol is no longer approved. The date after the end date of the approval period.
- 3.11 Finding of Non-Compliance: Non-Compliance in fact.

- 3.12 <u>Human Research</u>: Any activity that either:¹
 - 3.12.1 Is Research as Defined by DHHS and involves Human Subjects as Defined by DHHS; or
 - 3.12.2 Is Research as Defined by FDA and involves Human Subjects as Defined by FDA.
- 3.13 <u>Human Subject as Defined by DHHS</u>: A living individual about whom an investigator (whether professional or student) conducting research (1) obtains information or biospecimens through <u>Intervention</u> or <u>Interaction</u> with the individual, and uses, studies, or analyzes the information or biospecimens; or (2) obtains, uses, studies, analyzes, or generates identifiable private information or identifiable biospecimens. For the purpose of this definition:
 - 3.13.1 <u>Intervention</u>: Physical procedures by which information or biospecimens are gathered (for example, venipuncture) and manipulations of the subject or the subject's environment that are performed for research purposes.
 - 3.13.2 <u>Interaction</u>: Communication or interpersonal contact between investigator and subject.
 - 3.13.3 <u>Private Information</u>: Information about behavior that occurs in a context in which an individual can reasonably expect that no observation or recording is taking place, and information which has been provided for specific purposes by an individual and that the individual can reasonably expect will not be made public (for example, a medical record).
 - 3.13.4 <u>Identifiable Private Information</u>: Private Information for which the identity of the subject is or may readily be ascertained by the investigator or associated with the information.
 - 3.13.5 <u>Identifiable Biospecimen</u>: A biospecimen for which the identity or the subject is or may be readily ascertained by the investigator or associated with the biospecimen.
- 3.14 <u>Human Subject as Defined by FDA</u>: An individual who is or becomes a subject in research, either as a recipient of the test article or as a control. A subject may be either a healthy human or a patient. A human subject includes an individual on whose specimen a medical device is used.
- 3.15 Immediate Family: Spouse, domestic partner; and dependent children.
- 3.16 Institutional Official/ Organizational Official (IO/OO):
 - 3.16.1 Institutional Official (IO): Term utilized by DHHS.
 - 3.16.1.1 The Institutional Official (IO) is the individual who is legally authorized to act for the institution and, on behalf of the institution, obligates the institution to the Terms of the Assurance. The IO is responsible for ensuring that the Human Research Protection Program (HRPP) functions effectively and that the institution provides the resources and support necessary to comply with all requirements applicable to research involving human subjects. The IO represents the institution named in the Federalwide Assurance (FWA)². The IO Gary Ostrander, PhD,Vice President for Research.
 - 3.16.2 Organizational Official (OO): Term utilized by AAHRPP.
 - 3.16.2.1 An identified, knowledgeable leader of the HRPP who is responsible for the program and has the authority to implement the program. This individual may rely on others for the interpretation of laws, regulations, codes, and guidance and the day-to-day operations of the HRPP, and should have a basic understanding of the relevant laws, codes, regulations and guidance that govern research involving human participants, the responsibilities of

an organizational official, and the responsibilities of the IRB or EC and researchers and research staff in protecting research participants. This individual should be directly involved in the allocation of resources to the HRPP. In some circumstances, more than one individual serves in this capacity³.

- 3.17 <u>Institutional Profile</u>: A record of information an institution keeps about another collaborating institution/organization for one or more <u>Collaborative Studies</u> or <u>Multi-Site Studies</u>.
- 3.18 <u>Legally Authorized Representative (LAR)</u>: An individual or judicial or other body authorized under applicable law to consent on behalf of a prospective subject to the subject's participation in the procedures(s) involved in the research.
 - 3.18.1 If there is no applicable law addressing this issue, then this individual is recognized by institutional policy as acceptable for providing consent in the non-research context on behalf of the prospective subject to the subject's participation in the procedure(s) involved in the research.
 - 3.18.2 See "SOP: LARs, Children, and Guardians (HRP-013)" for who may serve as a Legally Authorized Representative at this institution.
- 3.19 <u>Minimal Risk</u>: The probability and magnitude of harm or discomfort anticipated in the research that are not greater in and of themselves than those ordinarily encountered in daily life or during the performance of routine physical or psychological examinations or tests.⁴
 - 3.19.1 For research involving prisoners <u>Minimal Risk</u> is the probability and magnitude of physical or psychological harm that is normally encountered in the daily lives, or in the routine medical, dental, or psychological examination of healthy persons.
 - 3.19.2 When following Department of Defense regulations, the definition of minimal risk based on the phrase "ordinarily encountered in daily life or during the performance of routine physical or physiological examination or tests" shall not be interpreted to include the inherent risks certain categories of human participants face in their everyday life. For example, the risks imposed in research involving human participants focused on a special population should not be evaluated against the inherent risks encountered in their work environment (e.g., emergency responder, pilot, soldier in a combat zone) or having a medical condition (e.g., frequent medical tests or constant pain).
- 3.20 <u>Multi-Site Study</u>: A study in which two or more institutions coordinate, with each institution completing all research activities outlined in a specific protocol.
- 3.21 Non-Committee Review: Any of the following:

3.21.1 Determination of whether an activity is Human Research.

- 3.21.2 Determination of whether Human Research is exempt from regulation.
- 3.21.3 Reviews of non-exempt research using the expedited procedure.
- 3.21.4 Determinations of which subjects can continue in expired research.
- 3.21.5 Concurrence of IRB Chair or designee for non-emergency individual patient/small group expanded access for an unapproved medical device (commonly known as

Compassionate Use) or non-emergency individual patient expanded access IND with request for authorization to use alternative IRB review procedures.

- 3.22 <u>Non-Compliance</u>: Failure to follow the regulations, or the requirements or determinations of the IRB.
 - 3.22.1 In the case of research funded or conducted by the Department of Defense (DOD), Non-Compliance includes failure of a person, group, or institution to act in accordance with Department of Defense (DOD) instruction 3216.02, its references, or applicable requirements
 - 3.22.2 In the case of Veterans Administration (VA) research, Non-Compliance is any failure to adhere to the requirements for conducting VA research covered by the VHA Handbook.
- 3.23 Participating Site (pSite): An institution that participates in a Single IRB (sIRB) Study.
- 3.24 <u>Prisoner</u>: Any individual involuntarily confined or detained in a penal institution. The term is intended to encompass individuals sentenced to such an institution under a criminal or civil statute, individuals detained in other facilities by virtue of statutes or commitment procedures which provide alternatives to criminal prosecution or incarceration in a penal institution, and individuals detained pending arraignment, trial, or sentencing.
 - 3.24.1 For Department of Defense (DOD) research the term includes military personnel in either civilian or military custody.
- 3.25 Related to the Research: A financial interest is Related to the Research when the interest is in:
 - 3.25.1 A sponsor of the research;
 - 3.25.2 A competitor of the sponsor of the research;
 - 3.25.3 A product or service being tested; or
 - 3.25.4 A competitor of the product or service being tested.
- 3.26 <u>Research as Defined by DHHS</u>: A systematic investigation, including research development, testing and evaluation, designed to develop or contribute to generalizable knowledge.
- 3.27 <u>Research as Defined by FDA</u>: Any experiment that involves a test article and one or more Human Subjects, and that meets any one of the following:
 - 3.27.1 Must meet the requirements for prior submission to the Food and Drug Administration under section 505(i) of the Federal Food, Drug, and Cosmetic Act meaning any use of a drug other than the use of an approved drug in the course of medical practice;
 - 3.27.2 Must meet the requirements for prior submission to the Food and Drug Administration under section 520(g) of the Federal Food, Drug, and Cosmetic Act meaning any activity that evaluates the safety or effectiveness of a device; OR
 - 3.27.3 Any activity the results of which are intended to be later submitted to, or held for inspection by, the Food and Drug Administration as part of an application for a research or marketing permit.
- 3.28 <u>Restricted</u>: Applies to investigators who are delinquent in meeting IRB requirements.
- 3.29 <u>Serious Non-Compliance</u>: <u>Non-Compliance</u> such that the failure to comply could adversely affect the rights, safety, or welfare of a human subject; place a human subject at increased risk of harm; cause harm to a human subject; affect a human subject's willingness to participate in research; or damage or compromise the scientific integrity of research data.
 - 3.29.1 For Department of Defense (DOD) research <u>Serious Non-Compliance</u> includes failure of a person, group, or institution to act in accordance with Department of Defense (DOD) Instruction 3216.02 and its references such that the failure could adversely affect the rights, safety, or welfare of a human subject; place a human subject at increased risk of harm; cause harm to a human subject; affect a human subject's willingness to participate in research; or damage or compromise the scientific integrity of research data.

- 3.29.2 For Veterans Administration (VA) research <u>Serious Non-Compliance</u> is any failure to adhere to requirements for conducting <u>Human Research</u> that may reasonably be regarded as:
 - 3.29.2.1 Presenting a genuine risk of substantive harm, to the safety, rights, or welfare of human research subjects, research personnel, or others, including their rights to privacy and confidentiality of identifiable private information; or
 - 3.29.2.2 Substantively compromising a Veterans Administration (VA) facility's human research protection programs (HRPP).
- 3.30 <u>Single IRB (sIRB) Study</u>: A study in which two or more institutions (participating sites, or pSites) coordinate to complete the research activities, but all institutions rely on a single institution's/organization's IRB for ethical review. The reviewing IRB may or may not be affiliated with any of the pSites.
- 3.31 <u>Suspension of IRB Approval</u>: An action of the IRB, IRB designee, <u>Institutional Official/Organizational Official</u>, or designee of the <u>Institutional Official/Organizational Official</u> to temporarily or permanently withdraw IRB approval of some or all research procedures short of a <u>Termination of IRB Approval</u>. Suspended studies remain open and are subject to continuing review.
 - 3.31.1 For Veterans Administration (VA) research, Suspension of IRB Approval:
 - 3.31.1.1 Refers to a temporary interruption in selected research activities (e.g., new enrollments or specific interventions) due to concerns about the safety, rights, or welfare of human subjects, research personnel, or others, regardless of whether the action was taken by an investigator, facility official, research review committee, or external entity.
 - 3.31.1.2 Does not refer to interruptions in research for other reasons, including the expiration of project approval periods.
- 3.32 Systematic: Having or involving a system, method, or plan
- 3.33 <u>Termination of IRB Approval</u>: An action of the IRB, IRB designee, <u>Institutional Official</u>, or designee of the <u>Institutional Official</u> to permanently withdraw IRB approval of all research procedures. Terminated studies are permanently closed and no longer require continuing review.
 - 3.33.1 For Veterans Administration (VA) research, Termination of IRB Approval:
 - 3.33.1.1 Refers to a permanent halt in all research activities due to concerns about the safety, rights, or welfare of human subjects, research personnel, or others, regardless of whether the action was taken by an investigator, facility official, research review committee, or external entity.
 - 3.33.1.2 Does not refer to interruptions in research for other reasons, including the expiration of project approval periods.
- 3.34 <u>Unanticipated Problem Involving Risks to Subjects or Others</u>: Any information that is (1) unanticipated, (2) related to the research, and (3) indicates that subjects or others are at increased risk of harm.
 - 3.34.1 For Department of Defense (DOD) research the term <u>Unanticipated Problem Involving</u>
 Risks to Subjects or Others includes any incident, experience, or outcome that meets
 ALL three of the following conditions:
 - Is unexpected (in terms of nature, severity, or frequency) given the procedures described in the research protocol documents (e.g., the IRB-approved research protocol and informed consent document) and the characteristics of the human subject population being studied.
 - 3.34.1.2 Is related or possibly related to participation in the research (in this Instruction, possibly related means there is a reasonable possibility that

the incident, experience, or outcome may have been caused by the procedures involved in the research).

- 3.34.1.3 Suggests that the research places human subjects or others at a greater risk of harm (including physical, psychological, economic, or social harm) than was previously known or recognized, even if no harm has actually occurred.
- 3.34.2 For Veterans Administration (VA) research:
 - 3.34.2.1 <u>Unanticipated Problem Involving Risks to Subjects or Others</u> would include any serious problem or local serious adverse event (SAE) that is both unanticipated and related to the research.
 - 3.34.2.2 The term "serious problem" include a problem in human research or research information security that may reasonably be regarded as:
 - 3.34.2.2.1 Presenting a genuine risk of substantive harm to the safety, rights, or welfare of human research subjects, research personnel, or others, including their rights to privacy and confidentiality of identifiable private information; or
 - 3.34.2.2.2 Substantively compromising a Veterans Administration (VA) facility's human research protection program (HRPP) or research information security program.
 - 3.34.2.3 The term "serious adverse event" refers to an untoward occurrence in human research that results in death, a life-threatening experience, inpatient hospitalization, persistent or significant disability or incapacity, congenital abnormality, or birth defect, or that requires medical, surgical, behavioral, social, or other intervention to prevent such outcome.
 - 3.34.2.4 The terms "unanticipated" and "unexpected" refer to an event or problem in human research that is new or greater than previously known in terms of nature, severity, or frequency, given the procedures described in protocol documents and the characteristics of the study population.
 - 3.34.2.5 The term "related" means the problem may reasonably be regarded as caused by, or probably caused by, the research.
